# KENTUCKY BOARD OF EMBALMERS AND FUNERAL DIRECTORS

## August 16, 2016

A regular meeting of the Kentucky Board of Embalmers and Funeral Directors was held at the Crowne Plaza in Louisville, Kentucky on Tuesday, August 16, 2016.

Chairman Percell called the meeting to order at 9:00 A.M. in the Carroll room.

A motion was made by Mr. Porter to approve the July minutes with any corrections needing to be made. Mr. Evans seconded the motion, was carried 5-0.

#### DALE POWELL'S REPORT

Mr. Powell submitted his report to the Board members. A motion was made by Mr. Porter to approve the Inspector's report with any corrections needing to be made. Mr. Coffey seconded the motion, it carried 5-0.

William R. Rust Funeral Home: Mr. Coffey made a motion to bring the manager before the Board to discuss the issues the Inspector found when he tried to inspect the Boston location on July 25, 2016. Mr. Porter seconded the motion and it carried 5-0.

Jones, Simpson & Gee Funeral Home: Mr. Coffey made a motioned to bring the manager before the Board to discuss the issues the Inspector found when he called the location. Mr. Porter seconded the motion and it carried 5-0.

<u>Adam Hills Funeral Home</u>: Dale found issues with the price list from the facility. Issues are as followed: 1<sup>st</sup> paragraph needs to be worded the correct way, hand written prices, pricing for caskets do not match. Mr. Meyer is going to contact Ms. Adams about correcting the issues with her General Price List.

## SCHELL'S REPORT

<u>Steve Ward</u>: Mr. Porter motioned to go into Executive Session with Mr. Percell recused from the discussion. Mr. Coffey seconded. Mr. Porter motioned to set a hearing for Mr. Ward, Mr. Coffey seconded the motion, and it carried 4-0 with Mr. Percell recused.

# **DISCUSSION**

Barr House Tributes: Emily Gaunce, Mr. Barr and their attorney, Steve Amato, met with the Board to discuss the issue with the license. Back on the record at 11:13 A.M. Mr. Amato requesting the Board issue the establishment license today. The city of Paris has several conditions that they want the establishment to follow and they were granted a conditional use permit from the city of Paris. One of these conditions is that no bodies are left there overnight. Dale went in February 2016 for a courtesy inspection and made the establishment aware of the issues that he found, which including parking, safety issues with steps entering the main chapel, and restrooms. According to Mr. Amato the issues with the parking, steps, and restrooms has now been resolved. Mr. Barr stated the establishment has passed all state and health department inspections. Mr. Percell made them aware that the sign has to read the same as what the establishment states. Mr. Barr said that the Bed & Breakfast part of the business will be "phased" out. Mr. Percell will have the inspector to go and do a final inspection so that the license can be issued. Emily Gaunce will be the manager of this visitation and ceremonial establishment in Paris.

Mr. Porter motioned to go into Executive Session to discuss the legal ramifications of the March approval of the establishment at 1:39 P.M. Mr. Coffey seconded the motion and carried 5-0. Mr. Amato argued the Executive Session would be against Open Meeting laws. Mr. Percell ruled to go into executive session due to subsection two of 61.815, Requirements for conducting closed sessions, of the open meeting laws. Back on record 1:58 P.M. There were not any actions taken in Executive Session. Mr. Coffey motioned for the approval to happen upon final inspection. The motion died with no second. Mr. Porter motioned for the matter be tabled until the Board's legal consultant can attend due to legal questions. Mr. Meyer seconded the motion. It carried 4-1.
