KENTUCKY BOARD OF EMBALMERS AND FUNERAL DIRECTORS May 09, 2017

A regular meeting of the Kentucky Board of Embalmers and Funeral Directors was held at the Crowne Plaza in Louisville on Tuesday, May 9, 2017.

Chairman Percell called the meeting to order at 9:01 A.M. in the Luersen Room.

Chairman Percell informed the Board that he and Ms. Dorsey met in Frankfort to discuss some changes that may be made to this Board and others by the Governor's office.

A motion was made by Mr. Porter to approve the April minutes with corrections. Mr. Coffey seconded the motion, it carried 5-0.

DALE POWELL'S REPORT

Mr. Powell submitted his report to the Board. A motion was made by Mr. Meyer to approve the Inspector's report with corrections. Mr. Porter seconded the motion, it carried 5-0.

<u>Hughes Funeral Home</u>: Mr. Powell reported to the Board about an advertisement by Hughes Funeral Home regarding an open house with door prizes. Mr. Coffey made a motion for a cease and desist be issued to the establishment. Mr. Porter seconded the motion and it carried 5-0.

LEGAL UPDATES

Elliott Mortuary: Telephonic prehearing conference was held on April 10, 2017. Another prehearing conference is scheduled for July 10, 2017. Mr. Meyer made a motion to schedule a hearing and it was agreed that the inspector needs to inspect Elliott Mortuary soon. Mr. Coffey seconded the motion and it carried 4-0 w/one extension.

<u>David Owen</u>: Mr. Porter made a motion to issue an Administrative Complaint regarding the Harry Carlisle pre-need funds. Mr. Meyer seconded the motion and it carried 5-0.

COMPLAINTS

<u>Fender Funeral Directors</u>: James Fender requested to meet with the Board to discuss the death certificate complaint and Agreed Order that was issued. Mr. Fender explained to the Board why it took so long to file the death certificate. There was not a doctor signature on the provisional so he could not file immediately. Also, when an investigator from Vital Statistics contacted Mr. Fender regarding the certificate not being filed. Mr. Fender then contacted UK hospital to get the doctor signature to file the completed death certificate. Mr. Fender asked for the Board to reduce his fine. No actions was taken.

<u>Letcher Funeral Home</u>: Mr. Porter made a motion for an Agreed Order be issued. Mr. Meyer seconded the motion and it carried 4-0 with Mr. Evans absent.

Neptune Society: Mr. Coffey made a motion for the inspector to look into the complaint regarding a death certificate. Mr. Evans seconded and it carried 5-0.

Neptune Society: Holly Warco, the district manager, and Treadrick Hayes, the establishment manager, met with the Board to discuss the complaint regarding free lunch and informational seminars. Poul LeMasters, their attorney, appeared by speaker phone for the discussion. The Board informed that if the terms "free lunch" and the "RSVP" is taken off the advertising then it would be fine. Mr. Porter made a motion to send an Agreed Order with a fine. Mr. Coffey seconded the motion and it carried 4-1. Mr. Porter withdrew his original motion, Mr. Coffey seconded the withdrawal. Mr. Porter made a motion to send an Agreed Order and the motion died. Mr. Coffey motioned to send an Agreed Order. Mr. Meyer seconded the motion and it carried 3-2.

<u>Cremation Society of Paducah</u>: Chairman Percell directed that the inspector to go to the establishment to investigate the terms of the lease and other issues raised in the complaint.

A.D. Porter & Son Funeral Home: Mr. Evans made a motion to dismiss the complaint. Mr. Coffey seconded the motion and it carried 4-0 w/Mr. Porter recused.

DISCUSSION

Stith Funeral Homes: The managers, Josh Marcum and Jeff Hayes of Stith Funeral Homes in Hebron, KY were summoned to appear before the Board. The inspector was unable to enter the establishment to inspect. Mr. Porter made a motion for an Agreed Order to be issued. Mr. Coffey seconded the motion and it carried 5-0.

Allison & Rose Funeral Home: Ronald Cook, the manager of Allison & Rose Funeral Home in Taylor Mill, KY were summoned to appear before the Board. When the inspector went to the funeral home for a routine inspection, no one was available to meet with him, Mr. Powell called the next day and left a message with the answering service with no return call. Mr. Cook explained that he is typically at the location every day, but leaves to handle other matters such as removals, items at the Covington location or to care for sick family member. Mr. Porter made a motion for an Agreed Order to be issued. Mr. Coffey seconded the motion and it carried 5-0.

Barnett-Strother Funeral Home, Slaughters-Hanson Chapel: Tom Hemmerle, the manager of Barnett-Strother Funeral Home, Slaughters-Hanson Chapel in Slaughters, KY were summoned to appear before the Board. The inspector was called by the funeral home to do the final inspection for the establishment license. When arriving at the funeral home a sign was out in the yard without a cover and the establishment was not ready for inspection. According to Mr. Powell and Mr. Hemmerle the sign is now covered but the funeral home is still not ready. Mr. Porter made a motion for an Agreed Order. Mr. Coffey seconded the motion and it carried 5-0.

<u>Charles McWhorter</u>: An apprentice from Bowling Funeral Home requested to meet with the Board to discuss his time served while he is in school and being able to apply for his Level 2 status. The Board discussed Apprenticeship to determine if any changes in current policy were appropriate. No actions were taken.
