#### Tuesday, August 8, 2017

Chairman Percell called the meeting to order at 9:00 A.M. in the Luersen Room. Mr. Porter left the meeting at 12:30 P.M.

Mr. Meyer made a motion to approve the July minutes with corrections. Mr. Porter seconded; it carried 5-0.

#### DALE POWELL'S REPORT

Mr. Powell submitted his report to the Board. Mr. Meyer made a motion to approve the Inspector's report with corrections. Mr. Evans seconded; it carried 5-0.

Young Funeral Home: Attorneys, Michael Lawrence and Jason Lawrence, and Kristy Rogers from Young Funeral Home in Louisa KY met with the Board to discuss issues regarding ownership of the funeral home and the managers of the establishment. Mr. Meyer made a motion to approve the renewal. Mr. Porter seconded; it carried 4-1 w/One Abstention.

#### **LEGAL**

Elliott Mortuary: Establishment has passed the inspection and license will be renewed.

David Owen: The case is completely closed and Agreed Order entered.

Letcher Funeral Home: Counsel Schell is still working on this issue.

Allison & Rose Funeral Home: Ms. Dorsey is still working on the RFP

Stith Funeral Homes: Ms. Dorsey is still working on the RFP.

<u>Filbeck-Cann & King Funeral Home</u>: Pre-hearing telephonic conference is scheduled for August 8, 2017.

<u>Cremation Society of Paducah</u>: Still waiting on the city of Paducah decision. Will be sent a cease and desist letter regarding an advertisement offering something of value (a "free" cremation kit) and a violation of FTC rule.

Neptune Society: Mr. Porter made a motion to rescind the motion and Mr. Meyer seconded and the previous motion was rescinded.

Osborne Funeral Home (Evansville, IN): Counsel Schell sent letters to the Indiana Board of Funeral Directors and Steve Gold, Henderson County Attorney regarding Stacia Ann Osborne-Christian. Stacia does not have a courtesy card and cannot perform services in Kentucky.

Glenn Taylor: Mr. Taylor had questions about changing the corporate setup for his establishment, Glenn Funeral Home and Crematory.

<u>Waddell-Whitt</u>: Counsel Schell will write a letter to the establishment to see if the death certificate has been issued and she copied the complainant.

<u>Everidge Funeral Home</u>: Counsel Schell will write a letter to the establishment to see if the payment has been made.

#### **ESTABLISMENT**

<u>Evans Monuments and Direct Cremation Services</u>: Emmett Ratterman met with the Board for approval of a visitation and ceremonial location in Louisville, KY. The full-service establishment location that it would be associated with is J.B. Ratterman and Sons Funeral Home and Ratterman Keenan Southeast Chapel. Mr. Meyer made a motion to approve establishment license, Mr. Evans seconded; it carried 3-2.

<u>Mullins Family Home</u>: Joseph Mullins met with the Board for approval of a full service establishment in Warfield, KY. The inspector has not been able to finish the inspection due to the state building inspector showing up at the same time. Mr. Mullins was issued a temporary business license that expires in 90 days. The Board cannot approve the license until a permanent business license has been issued.

<u>Woodlawn Cremation & Funerals.</u> Agape on Broadway: Trent Hole met with the Board for a name change. Mr. Evans made a motion to approve the name change, Mr. Coffey seconded; it carried 5-0.
