A regular meeting of the Kentucky Board of Embalmers and Funeral Directors was held at the Kentucky Fair and Expo Center in Louisville on Tuesday, June 7, 2017.

At 9:00 A.M. Oral Embalming and the Funeral Director exams were given. At 1:00 P.M Laws exams were given.

Tuesday, June 6, 2017

Mr. Coffey called roll for the Written Embalmer exam in the meeting room B-106. Chairman Percell called the meeting to order at 1:04 P.M. in the Meeting Room B-108.

A motion was made by Mr. Meyer to approve the May minutes with corrections. Mr. Porter seconded the motion, and it carried 5-0.

DALE POWELL'S REPORT

Mr. Powell submitted his report to the Board. A motion was made by Mr. Meyer to approve the Inspector's report with corrections. Mr. Evans seconded the motion and it carried 5-0.

<u>Mark Wood</u>: Counsel Schell proposed to send a letter of notice that the Board has voted not to renew his license because of pleading guilty to charges in Hancock County. Mr. Coffey made a motion to send the letter, Mr. Porter seconded the motion and it carried 5-0.

<u>Neptune Society</u>: Mr. Porter made a motion that Sandra Cook be summoned to the next Board meeting regarding misfiling of a death certificate. Mr. Meyer seconded the motion and it carried 4-0.

<u>Schmid Funeral Home</u>: Mr. Meyer made a motion to send a cease and desist letter regarding advertising. Mr. Coffey seconded the motion and it carried 4-0.

<u>Cremation Society of Paducah</u>: Peter Ostermiller, Attorney for Cremation Society of Paducah, met with the Board to discuss what the lease includes versus what the actual building is used for. Per 201 KAR 15:110 explains the general requirements for an establishment license and following local statues and regulations. Mr. Meyer made a motion to send a notification that the establishment has until July 31, 2017 to make a decision. Mr. Coffey seconded the motion and it died 2-2. Mr. Evans made a motion to give notification and they have 20 days to respond. Mr. Meyer seconded the motion and it carried 4-0.

Filbeck-Cann & King Funeral Home: Mr. Meyer made a motion to file an Administrative Complaint to be set for hearing for William Roberts, it was seconded by Mr. Coffey, it carried 3-1. <u>Barr House Tribute</u>: The website has been corrected. The Board office will be mailing a letter to all establishments with the renewal sticker advising to identify unlicensed personnel as staff or employees instead of funeral associate, attendant, visitation attendant, or other like labels.

<u>Letcher Funeral Home</u>: Mr. Meyer made a motion to keep the issue on the agenda and Counsel Schell will contact the attorney about the filing of the death certificate. Mr. Coffey seconded the motion and it carried 4-0.

<u>Stith Funeral Homes</u>: Mr. Meyer made a motion that the Agreed Order be re-sent by certified mail a second time due to no response with a 10-day return. Mr. Evans seconded the motion and it carried 4-0.

Ms. Schell asked that if Agreed Orders are still pending they stay on the agenda until the Order and fine is received and signed. The Board agreed.
