Inspectors Report March 20, 2023 – April 6, 2023

To whom it may concern:

Inspector Webb traveled to and performed routine inspections on 50 funeral homes and verified 26 apprentices had their calendars up to date from March 20, 2023 to April 6, 2023.

This inspector observed the following regarding Campbell- Fisher Funeral Home in Lebanon, KY and thought the Board should be aware of the following:

On March 23, 2023, at approximately 9:00 A.M. this Inspector arrived at Campbell-Fisher Funeral Home. Business address noted to be W. Main Street, Lebanon, KY 40033. Upon entering the facility there was noted to be a very strong cat urine odor. Several dark spots noted throughout the facility on the carpet and furniture. Cat also noted to be present in the funeral home, along with cat food. This inspector did not see a litter box but the smell in the facility was apparent. Three employees noted to be in the facility along with the owner, Rebecca Fisher, Licensed Embalmer and Funeral Director. She was outside the prep room dressing a deceased person with the help of an employee. Facilities were very cluttered and just overall dirty throughout. Ms. Fisher said she no longer used her show room that she used catalogues. She did walk this inspector into the show room and there was noted to be 3 caskets on biers and 2 kayaks on the floor. The outside of the funeral home noted to have structural and roof issues.

When questioned regarding the facility the owner stated she had been very busy. She stated the cat brought comfort to families but then contradicted herself saying that she put the cat up when families were in the funeral home. The owner also had her personal motorcycle parked in the chapel. She said she moved the motorcycle before services. This inspector asked why the motorcycle was parked in the funeral home. Rebecca Fisher stated, "Where does it state it can't be?" "And where does it say I can't have a cat in here?" This inspector replied, "I don't know if it is stated anywhere but I also don't understand why they are in here. This is a professional place of business. The overall facility is a cluttered mess, and the cat odor is very strong." Rebecca Fisher went on to say some families enjoyed the cat around, but she did also say she put the cat up when families were in. This inspector took a couple pictures of the cat and the motorcycle. I informed Ms. Fisher I would be checking on these things and putting my findings into a report. She replied, "OK."
