To whom it may concern:

Inspector Webb traveled to and performed routine inspections on 45 funeral home and checked in on 20 apprentices from July 10, 2023 to August 4, 2023.

On August 2, 2023, this inspector performed a routine inspection at Barbourville Funeral Home in Barbourville, Kentucky. This inspector discovered the owner Larry Hickerson in the office at the funeral home. I instructed him I was there for a routine, walk through inspection. He stated he was not prepared for me, but he would get it over with, that his prep room was a mess. Upon inspection of the prep room this inspector noted it to be dirty, cluttered and in unsanitary operable conditions. There was laundry on the floor, dirty gloves stacked, dirty instruments along with a foul odor. The room had not been cleaned in any recent time. This inspector took photographs of the area for records and instructed Mr. Hickerson he had 7 days to provide proof of a clean prep room. The conditions of the prep room were unacceptable among any standards. Mr. Hickerson voiced understanding and stated he would get his prep room cleaned up asap. We also discussed the risks associated with the unsanitary conditions of the prep room. This inspector documented the findings in her routine inspection report and reminded Mr. Larry Hickerson he had 7 days to provide proof of a clean prep room. Mr. Hickerson stated he recently had some personal health conditions effecting his strength and ability to work as usual. We discussed due to his health issues he may need to hire staff to assist in duties he is not able to perform. He voiced that he understood this suggestion.
