To whom it may concern:

Inspector Webb traveled to and performed routine inspections on 42 funeral homes and checked in on 10 apprentices from August 7, 2023 to September 8, 2023.

On August 31, 2023 this inspector stopped in at Legacy Funeral Center Nunnelley Chapel. Upon entering the facility there was noted to only be a funeral director's license displayed at this full-service facility. I phoned Scott Moyes, manager of the facilities, he stated he was unaware the licensure was not there but that he would rectify the problem as soon as possible. The following day he forwarded this inspector a photo of the proper licensure displayed at the facility. He also sent a photo of the paid receipt dated September 1, 2023 from KBEFD for manager change.

On September 7, 2023 this inspector stopped in at Dunn's Funeral Home. Upon entering the prep room there was noted to be dried blood on the embalming table and linens on the floor. Instructed the owner, Kyle Dunn to clean embalming table and properly store or launder clean, and dirty linens. The owner voiced understanding.

On August 14, 2023 this inspector visited and inspected Hornbeak Funeral Home, formerly Strong Funeral Home in Hickman, KY. Facility recently remodeled, new paint, flooring and furniture. Proper signage displayed and new owners on site. Facility received establishment license upon completion of inspection.

On August 21, 2023 this inspector visited and inspected Roberson Funeral Home in South Shore, KY. The facility was neat, clean and pricing within FTC compliance. New owners were presented with their establishment license upon completion of inspection.

On August 29, 2023 this inspector visited Gash Memorial Funeral Home, soon to be named Noon & Son Funeral Home. Eddie Noon along with other licensed staff were noted to be on site. The facility was noted to have new paint in the office and was neat and clean upon inspection. Pricing noted to be within FTC compliance. Upon completion of inspection, the facility was noted to be ready for new licensure upon reviewal from the board.
